IT IS FURTHER ORDERED that the assignments as made by this Executive Order shall continue in effect until superseded by a subsequent Executive Order or Act of the Legislature or until inauguration of a subsequent Governor. It shall be the duty of each board, commission, agency or other entity of the executive branch of state government to facilitate the purposes of this Order and the Executive Branch Reform Act of 1986 and to cooperate fully with designated cabinet secretaries.

IT IS FURTHER ORDERED that Executive Order 88-07 is hereby rescinded.
