An Act relating to the State Board of Education; amending Section 1, Chapter 421, O.S.L. 2009, as amended by Section 1, Chapter 449, O.S.L. 2009, Section 3, Chapter 449, O.S.L. 2009 and Section 3, Chapter 421, O.S.L. 2009, which relate to appropriations and expenditure authorizations; modifying appropriation amount; modifying expenditure authorizations; making appropriations; stating purposes; making appropriations exempt from fiscal year limitations; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY Section 1, Chapter 421, O.S.L. 2009, as amended by Section 1, Chapter 449, O.S.L. 2009, is amended to read as follows:

Section 1. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2010, the sum of ~~One Billion One Hundred Eighty-one Million One Hundred Ninety-four Thousand Four Hundred Dollars (\$1,181,194,400.00)~~ Nine Hundred Ninety-nine Million Five Hundred Ninety-one Thousand Four Hundred Fifteen Dollars (\$999,591,415.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 2. AMENDATORY Section 3, Chapter 449, O.S.L. 2009, is amended to read as follows:

Section 3. The State Board of Education is hereby authorized to expend from the Education Stabilization component of the American Recovery and Reinvestment Act Fund ("490 Fund"), the sum of ~~One Hundred Sixty-seven Million Five Hundred Fifty-nine Thousand Six Hundred Fifty-one Dollars (\$167,559,651.00)~~ Two Hundred Four Million Seven Hundred Eleven Thousand Six Hundred Sixteen Dollars (\$204,711,616.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Education by law.

SECTION 3. AMENDATORY Section 3, Chapter 421, O.S.L. 2009, is amended to read as follows:

Section 3. The State Board of Education is hereby authorized to expend during the fiscal year ending June 30, 2010, from the Common Education Technology Revolving Fund of the State Treasury, the sum of ~~Thirty-three Million One Hundred Ninety-six Thousand Eight Hundred Ninety-three Dollars (\$33,196,893.00)~~ Forty-seven Million Three Hundred Seventy-two Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Fifteen Million Six Hundred Fifty-five Thousand Five Hundred Ninety-eight Dollars (\$15,655,598.00) or so much thereof as may be necessary for financial support of public schools.

SECTION 5. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury, the sum of Fifty Million Dollars (\$50,000,000.00) or so much thereof as may be necessary to replace the shortfall in revenue authorized to be expended from the Education Reform Revolving Fund created in Section 34.89 of Title 62 of the Oklahoma Statutes.

SECTION 6. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury, the sum of One Hundred Forty-three Million Seven Hundred Fourteen Thousand Nine Hundred Seventy-six Dollars (\$143,714,976.00) or so much thereof as may be necessary for financial support of public schools.

SECTION 7. Appropriations made by Sections 4 through 6 of this act shall not be subject to fiscal year limitations and shall be available for encumbrance and expenditure purposes for a period of thirty (30) months from the effective date of this act.

SECTION 8. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
