

# An Act

An Act relating to the Oklahoma Health Care Authority; amending Section 69, Chapter 421, O.S.L. 2009, which relates to the Oklahoma Health Care Authority; amending appropriation amount; authorizing transfer; making an appropriation; stating purpose; exempting appropriations from agency category and budget limits; exempting transfer from agency category and budget limits; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY Section 69, Chapter 421, O.S.L. 2009, is amended to read as follows:

Section 69. There is hereby appropriated to the Oklahoma Health Care Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2010, the sum of ~~Five Hundred Eighty-one Million Forty Thousand Four Hundred Twelve Dollars (\$581,040,412.00)~~ Four Hundred Sixty-nine Million Three Hundred Eighty-nine Thousand Five Hundred Seventy-six Dollars (\$469,389,576.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Health Care Authority by law.

SECTION 2. The Oklahoma Health Care Authority is hereby authorized to transfer from the American Recovery and Reinvestment Act Fund ("490") to the CMIA Programs Disbursing Fund ("340") of the

Oklahoma Health Care Authority, the sum of One Hundred Fourteen Million Six Hundred Fifty Thousand Eight Hundred Thirty-six Dollars (\$114,650,836.00) or so much as may be necessary to perform the duties imposed on the Oklahoma Health Care Authority by law.

SECTION 3. There is hereby appropriated to the Oklahoma Health Care Authority from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury, the sum of Thirty Million Dollars (\$30,000,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Health Care Authority by law.

SECTION 4. The appropriations and authorized transfers made by this act shall not be subject to fiscal year 2010 agency category and budget limits.

SECTION 5. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.




