WHEREAS, this two-day clinic held in Tulsa, called "Oklahoma Mission of Mercy", treated more than 1,800 patients free of charge; and


WHEREAS, the Oklahoma House of Representatives wishes to express appreciation to Dr. Wood for his many contributions through providing service to others.
