An Act relating to wildlife; specifying a legal hunting method during certain hunting seasons; repealing 29 O.S. 2001, Sections 5-209, as last amended by Section 1, Chapter 85, O.S.L. 2009, 5-210, as last amended by Section 2, Chapter 85, O.S.L. 2009, and 5-211, as amended by Section 3, Chapter 136, O.S.L. 2008 (29 O.S. Supp. 2009, Sections 5-209, 5-210 and 5-211), which relate to crossbow permits and prohibitions; providing for codification; providing an effective date; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 213 of Title 29, unless there is created a duplication in numbering, reads as follows:

The use of crossbows and conventional longbows with a device that permits the bow to be held mechanically at full or partial draw, shall be a legal hunting method during any open season when conventional longbows are a legal means of take.

SECTION 2. REPEALER 29 O.S. 2001, Section 5-209, as last amended by Section 1, Chapter 85, O.S.L. 2009 (29 O.S. Supp. 2009, Section 5-209), is hereby repealed.



SECTION 4. REPEALER 29 O.S. 2001, Section 5-211, as amended by Section 3, Chapter 136, O.S.L. 2008 (29 O.S. Supp. 2009, Section 5-211), is hereby repealed.

SECTION 5. This act shall become effective July 1, 2010.


