He taught history and government for more than 20 years, mostly at Pioneer High School in Waukomis. He also served as Principal at Glencoe Junior High School and taught at Phillips University; and

WHEREAS, Robert Milacek proudly served in the Oklahoma State House of Representatives from 1976-1982 and in the Oklahoma State Senate from 1996 to 2004; and
