An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the State Board of Education, the Oklahoma Arts Council, the State Board of Career and Technology Education, the Commissioners of the Land Office, the Oklahoma Educational Television Authority, the Oklahoma State Regents for Higher Education, the Oklahoma Department of Libraries, the Physician Manpower Training Commission, the Oklahoma Board of Private Vocational Schools, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the Oklahoma Commission for Teacher Preparation, the Office of the State Auditor and Inspector, the Office of the State Bond Advisor, the Department of Central Services, the State Election Board, the Oklahoma Department of Emergency Management, the Ethics Commission, the Office of State Finance, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Office of Personnel Management, the Office of the Secretary of State, the Oklahoma State Senate, the Oklahoma Space Industry Development Authority, the Oklahoma Tax Commission, the Office of the State Treasurer, the Department of Transportation, the State Department of Health, the Oklahoma Health Care Authority, the J.D. McCarty Center for Children with Developmental Disabilities,

the Department of Mental Health and Substance Abuse Services, the University Hospitals Authority, the Oklahoma Department of Veterans Affairs, the Oklahoma Commission on Children and Youth, the Office of Disability Concerns, the Department of Human Services, the Oklahoma Indian Affairs Commission, the Office of Juvenile Affairs, the State Department of Rehabilitation Services, the Oklahoma Department of Agriculture, Food, and Forestry, the Oklahoma Department of Commerce, the Rural Economic Action Plan Fund, the Oklahoma Conservation Commission, the Department of Consumer Credit, the Corporation Commission, the Department of Environmental Quality, the Oklahoma Historical Society, the Oklahoma Horse Racing Commission, the Insurance Department, the J.M. Davis Memorial Commission, the Department of Labor, the Department of Mines, the Scenic Rivers Commission, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board, the Will Rogers Memorial Commission, the Alcoholic Beverage Laws Enforcement Commission, the Department of Corrections, the Office of the State Fire Marshal, the Oklahoma State Bureau of Investigation, the Council on Law Enforcement Education and Training, the Board of Medicolegal Investigations, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, the Department of Public Safety, the Office of the Attorney General, the Court of Criminal Appeals, district attorneys and the District Attorneys Council, the Supreme Court, the Oklahoma Indigent Defense System, the Council on Judicial Complaints, the Pardon and Parole Board and the Workers' Compensation Court; stating amounts of the appropriations; stating purposes and restrictions; authorizing and requiring certain expenditures; authorizing and requiring certain transfers; requiring certain deposit; and providing an effective date.

SUBJECT: General appropriations

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

SECTION 1. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of One Billion One Hundred Million Six Hundred Forty Thousand Five Hundred Seventy-one Dollars (\$1,100,640,571.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Education Reform Revolving Fund created in Section 34.89 of Title 62 of the Oklahoma Statutes, the sum of Six Hundred Thirty-four Million Eight Hundred Ninety-four Thousand Five Hundred Sixty-nine Dollars (\$634,894,569.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. The State Board of Education is hereby authorized to expend during the fiscal year ending June 30, 2012, from the Common Education Technology Revolving Fund of the State Treasury, the sum of Forty-seven Million Three Hundred Seventy-two Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Two Million Eight Hundred Fifty Thousand Dollars (\$2,850,000.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 5. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Twenty-five Million Nine Hundred Thousand Nine Hundred Eighty-five Dollars (\$25,900,985.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 6. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2010, the sum of Two Million Nine Hundred Sixty-nine Thousand Eight Hundred Four Dollars

(\$2,969,804.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 7. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Four Hundred One Million Two Hundred Twenty-four Thousand Six Hundred Fifty-five Dollars (\$401,224,655.00) or so much thereof as may be necessary for the support of public schools activities.

SECTION 8. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Thirty-three Million Dollars (\$33,000,000.00) or so much thereof as may be necessary for instructional expenses.

SECTION 9. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Twenty-one Million Four Hundred Twenty-six Thousand Six Hundred Forty-two Dollars (\$21,426,642.00) or so much thereof as may be necessary for administrative and support functions of the State Department of Education.

SECTION 10. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Two Million Eight Hundred Seventy-seven Thousand Eight Hundred Eighty-seven Dollars (\$2,877,887.00) or so much thereof as may be necessary for transfer to the School Consolidation Assistance Fund.

SECTION 11. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2010, the sum of Three Hundred Twenty-nine Thousand Nine Hundred Seventy-eight Dollars (\$329,978.00) or so much thereof as may be necessary for transfer to the School Consolidation Assistance Fund.

SECTION 12. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Two Million Eight

Hundred Seventy-seven Thousand Eight Hundred Eighty-seven Dollars (\$2,877,887.00) or so much thereof as may be necessary for transfer to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

SECTION 13. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2010, the sum of Three Hundred Twenty-nine Thousand Nine Hundred Seventy-eight Dollars (\$329,978.00) or so much thereof as may be necessary for transfer to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

SECTION 14. There is hereby appropriated to the Oklahoma Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Four Million Ten Thousand Eighty-seven Dollars (\$4,010,087.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Arts Council by law.

SECTION 15. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of One Hundred Thirty Million Two Hundred Thirteen Thousand Nine Hundred Sixty-six Dollars (\$130,213,966.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Career and Technology Education by law.

SECTION 16. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Three Million One Hundred Sixty-five Thousand Six Hundred Seventy-six Dollars (\$3,165,676.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the State Board of Career and Technology Education for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the State Board of Career and Technology Education.

SECTION 17. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2010, the sum of Three Hundred Sixty-two Thousand Nine Hundred Seventy-six Dollars

(\$362,976.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the State Board of Career and Technology Education for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the State Board of Career and Technology Education.

SECTION 18. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Seven Million One Hundred Nine Thousand Dollars (\$7,109,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 19. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Three Million Eight Hundred Twenty-two Thousand Three Hundred Twenty-eight Dollars (\$3,822,328.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 20. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Seven Hundred Fifty-three Million Three Hundred Seventy-five Thousand Three Hundred Two Dollars (\$753,375,302.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education. Of those funds appropriated, the sum of Three Million Eight Hundred Thirty Thousand Thirty-eight Dollars (\$3,830,038.00) shall be transferred to the Oklahoma Tuition Equalization Grant Trust Fund to implement the provisions of the Oklahoma Tuition Equalization Grant Act.

SECTION 21. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2012, the sum of Forty-seven Million Three Hundred Seventy-two Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the

Higher Education Capital Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 22. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2012, the sum of Forty-seven Million Three Hundred Seventy-two Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the Oklahoma Student Aid Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 23. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Sixty-five Million Dollars (\$65,000,000.00) for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 24. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the proceeds of the sale of bonds deposited in the Oklahoma Building Bonds of 1992 Fund A in the State Treasury, the sum of One Hundred Seventy-four Dollars (\$174.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 25. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the proceeds of the sale of bonds deposited in the

Oklahoma Building Bonds of 1992 Fund B in the State Treasury, the sum of Seventy-one Dollars (\$71.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 26. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of One Million Two Hundred Thirty-four Thousand One Hundred Seventy-four Dollars (\$1,234,174.00) or so much thereof as may be necessary for expenditures for concurrent enrollment pursuant to Section 628.13 of Title 70 of the Oklahoma Statutes.

SECTION 27. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Twenty-two Million Seven Hundred Thirty-five Thousand Three Hundred Nine Dollars (\$22,735,309.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education or for any other purpose authorized by paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes.

SECTION 28. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2010, the sum of Two Million Six Hundred Six Thousand Eight Hundred Twenty-eight Dollars (\$2,606,828.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education or for any other purpose authorized by paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes.

SECTION 29. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Four Million Nine Hundred Two Thousand Five Hundred Fifty Dollars (\$4,902,550.00) or so much thereof as may be necessary for the general operating budget of the Administrative Offices of the Oklahoma State Regents for Higher Education.

SECTION 30. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Six Hundred Sixty-one Thousand Two Hundred Seventy-one Dollars (\$661,271.00) or so much thereof as may be necessary for the Office of Accountability to perform the duties imposed upon the Office of Accountability by law.

SECTION 31. There is hereby appropriated to the Oklahoma Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Five Million Eight Hundred Ninety-eight Thousand Six Hundred Thirty-three Dollars (\$5,898,633.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Libraries by law.

SECTION 32. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Three Million Nine Hundred Seventy-nine Thousand Two Hundred Fifty-four Dollars (\$3,979,254.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 33. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Four Hundred Thousand Dollars (\$400,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 34. The Oklahoma Board of Private Vocational Schools is hereby authorized to expend during the fiscal year ending June 30,

2012, from the Oklahoma Board of Private Vocational Schools Revolving Fund of the State Treasury, the sum of One Hundred Sixty-seven Thousand One Hundred Ninety-four Dollars (\$167,194.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Board of Private Vocational Schools by law.

SECTION 35. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Six Million Eighty-two Thousand Two Hundred Seventy-four Dollars (\$6,082,274.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 36. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Seventeen Million Eight Hundred Eleven Thousand Four Hundred Forty-nine Dollars (\$17,811,449.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law. Of those funds appropriated, the sum of Seventeen Million One Hundred Twenty-four Thousand One Hundred Nine Dollars (\$17,124,109.00) shall be deposited in the Research Support Revolving Fund created pursuant to Section 5060.11 of Title 74 of the Oklahoma Statutes.

SECTION 37. There is hereby appropriated to the Oklahoma Commission for Teacher Preparation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of One Million Five Hundred Twenty-six Thousand One Hundred Seventy-nine Dollars (\$1,526,179.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Commission for Teacher Preparation by law.

GENERAL GOVERNMENT AND TRANSPORTATION

SECTION 38. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Four Million Three Hundred Ninety-nine Thousand Eight Hundred Twenty Dollars (\$4,399,820.00) or so much thereof as may be necessary to perform

the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 39. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Three Hundred Seven Thousand One Hundred Sixty-six Dollars (\$307,166.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on County Government Personnel Education and Training. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 40. There is hereby appropriated to the Office of the State Bond Advisor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of One Hundred Forty-three Thousand One Hundred Twelve Dollars (\$143,112.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Bond Advisor by law.

SECTION 41. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Fourteen Million Eight Hundred Eighty-eight Thousand Nine Hundred Seventy-eight Dollars (\$14,888,978.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 42. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of One Million Three Hundred Eighty-four Thousand Four Hundred Sixteen Dollars (\$1,384,416.00) to be transferred to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 43. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 2010, the sum of One Million Thirty-nine Thousand Nine Hundred Seven Dollars (\$1,039,907.00) or so much thereof as may be necessary to be transferred to the Building and Facility

Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 44. REAPPROPRIATION AND REDESIGNATION The amount of Nine Hundred Seventy-eight Thousand Seven Hundred Six Dollars (\$978,706.00) of the original appropriation of Nine Hundred Seventy-eight Thousand Seven Hundred Six Dollars (\$978,706.00), appropriated to the Department of Central Services by Section 1, Chapter 424, O.S.L. 2008, from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury, for the fiscal year ending June 30, 2009, for debt service on a bond for purposes of construction of Zink Dam improvements, stream bank stabilization and construction of two additional low water dams on the Arkansas River in Tulsa County, is hereby reappropriated and redesignated for the duties imposed upon the Department of Central Services by law. If, on the date this act is approved, any of the amount originally appropriated, as adjusted by expenditures, encumbrances and transfers, results in an unencumbered balance less than the reappropriated and redesignated amount, that reappropriated and redesignated amount is reduced to the unencumbered amount.

SECTION 45. REAPPROPRIATION AND REDESIGNATION The amount of One Hundred Twenty-seven Thousand One Hundred Seventy-two Dollars (\$127,172.00) of the original appropriation of One Hundred Twenty-seven Thousand One Hundred Seventy-two Dollars (\$127,172.00), appropriated to the Department of Central Services by Section 2, Chapter 424, O.S.L. 2008, from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury, for the fiscal year ending June 30, 2007, for debt service on a bond for purposes of construction of Zink Dam improvements, stream bank stabilization and construction of two additional low water dams on the Arkansas River in Tulsa County, is hereby reappropriated and redesignated for the duties imposed upon the Department of Central Services by law. If, on the date this act is approved, any of the amount originally appropriated, as adjusted by expenditures, encumbrances and transfers, results in an unencumbered balance less than the reappropriated and redesignated amount, that reappropriated and redesignated amount is reduced to the unencumbered amount.

There is hereby appropriated to the Insurance Department from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of One Million Eight Hundred Seventy-one Thousand Nine Hundred Thirty-seven Dollars (\$1,871,937.00) or so much thereof as may be necessary to perform the duties imposed upon the Insurance Department by law.

SECTION 105. TRANSFER The Director of the Office of State Finance shall transfer the sum of Five Million Dollars (\$5,000,000.00) from the State Insurance Commissioner Revolving Fund ("200 FUND") to the Special Cash Fund of the State Treasury.

SECTION 106. There is hereby appropriated to the J.M. Davis Memorial Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Three Hundred Six Thousand Nine Dollars (\$306,009.00) or so much thereof as may be necessary to perform the duties imposed upon the J.M. Davis Memorial Commission by law.

SECTION 107. There is hereby appropriated to the Department of Labor from any monies not otherwise appropriated from the Special Occupational Health and Safety Fund for the fiscal year ending June 30, 2012, the sum of One Million Four Hundred Seventy-one Thousand Seventy-five Dollars (\$1,471,075.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Labor by law.

SECTION 108. There is hereby appropriated to the Department of Labor from any monies not otherwise appropriated from the Special Occupational Health and Safety Fund for the fiscal year ending June 30, 2010, the sum of One Million Two Hundred Thirty-six Thousand Four Hundred Twenty-five Dollars (\$1,236,425.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Labor by law.

SECTION 109. There is hereby appropriated to the Department of Labor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Three Hundred Seventy-three Thousand Six Hundred Sixty Dollars (\$373,660.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Labor by law.

SECTION 110. There is hereby appropriated to the Department of Mines from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Seven Hundred Seventy-nine Thousand One Hundred Thirty-nine Dollars (\$779,139.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Mines by law.

SECTION 111. There is hereby appropriated to the Scenic Rivers Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Two Hundred Seventy-one Thousand Three Hundred Fifteen Dollars (\$271,315.00) or so much thereof as may be necessary to perform the duties imposed upon the Scenic Rivers Commission by law. The monies appropriated in this section shall be transferred to the Scenic Rivers Commission Revolving Fund created pursuant to Section 1462A of Title 82 of the Oklahoma Statutes.

SECTION 112. There is hereby appropriated to the Oklahoma Tourism and Recreation Department from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Twenty-one Million Eight Hundred Three Thousand Three Dollars (\$21,803,003.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Tourism and Recreation Department by law.

SECTION 113. There is hereby appropriated to the Oklahoma Water Resources Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Five Million Four Hundred Ninety-nine Thousand Six Hundred Seventy-one Dollars (\$5,499,671.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Water Resources Board by law.

SECTION 114. There is hereby appropriated to the Will Rogers Memorial Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Seven Hundred Forty Thousand Four Hundred Eighty-six Dollars (\$740,486.00) or so much thereof as may be necessary to perform the duties imposed upon the Will Rogers Memorial Commission by law.

PUBLIC SAFETY

SECTION 115. There is hereby appropriated to the Alcoholic Beverage Laws Enforcement Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Three Million One Hundred Forty Thousand Three Hundred Thirty-four Dollars (\$3,140,334.00) or so much thereof as may be necessary to perform the duties imposed upon the Alcoholic Beverage Laws Enforcement Commission by law.

SECTION 116. There is hereby appropriated to the Department of Corrections from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Four Hundred Nine Million Eight Hundred Thirty-one Thousand Sixty-eight Dollars (\$409,831,068.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Corrections by law.

SECTION 117. There is hereby appropriated to the Department of Corrections from any monies not otherwise appropriated from the Special Cash Fund, the sum of Fifty Million Dollars (\$50,000,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Corrections by law.

SECTION 118. There is hereby appropriated to the Office of the State Fire Marshal from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of One Million Seven Hundred Ninety-six Thousand Seven Hundred Sixty-four Dollars (\$1,796,764.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Fire Marshal by law.

SECTION 119. There is hereby appropriated to the Oklahoma State Bureau of Investigation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Thirteen Million Eight Hundred Forty-eight Thousand Fifty-nine Dollars (\$13,848,059.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma State Bureau of Investigation by law. Of the funds appropriated herein, a maximum of Fifty Thousand Dollars (\$50,000.00) may be transferred to an agency special account for the purpose of purchasing evidence items, paying fees to informers or special employees, paying expenses incurred in the prosecution and defense of civil actions, and paying other expenses as incurred under the Evidence Fund activity in trying to apprehend and convict violators of the laws of the state. The Oklahoma State Bureau of Investigation shall report income to the Evidence Fund annually pursuant to the provisions of Sections 34.42 and 34.36 of Title 62 of the Oklahoma Statutes.

SECTION 120. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the C.L.E.E.T. Fund for the fiscal year ending June 30, 2012, the sum of Three Million Two Hundred Twenty-six

Thousand Five Hundred Sixty-five Dollars (\$3,226,565.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 121. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Two Hundred Fifty-five Thousand Nine Hundred Ninety-five Dollars (\$255,995.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 122. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Two Hundred Thousand Dollars (\$200,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 123. There is hereby appropriated to the Board of Medicolegal Investigations from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Four Million Six Hundred Ninety-eight Thousand Two Hundred Eighty-one Dollars (\$4,698,281.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Medicolegal Investigations by law.

SECTION 124. There is hereby appropriated to the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Three Million Six Hundred Sixteen Thousand Four Hundred Eighteen Dollars (\$3,616,418.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control by law.

SECTION 125. There is hereby appropriated to the Department of Public Safety from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Eighty-four Million Eight Hundred Ninety-four Thousand Seven Hundred Ninety Dollars (\$84,894,790.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Public Safety by law.

SECTION 126. The Department of Public Safety is hereby authorized to expend Thirteen Million Dollars (\$13,000,000.00) from the Department of Public Safety Patrol Vehicle Revolving Fund for the fiscal year ending June 30, 2012, for the purchase of patrol vehicles, patrol aircraft, and the equipping of those vehicles, as well as other operational expenses of the Oklahoma Highway Patrol.

SECTION 127. For the fiscal year ending June 30, 2012, the Department of Public Safety is authorized to have one Patrol Academy with no more than forty (40) cadets.

SECTION 128. REAPPROPRIATION Of the Ninety-eight Million Three Hundred Seventy Thousand Three Hundred Ninety-one Dollars (\$98,370,391.00) originally appropriated to the Department of Public Safety by Section 119, Chapter 317, O.S.L. 2007, from monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, to perform the duties imposed upon the Department of Public Safety by law, One Million Two Hundred Thousand Dollars (\$1,200,000.00) is hereby continued and reappropriated for the purpose of construction of a new Troop K Headquarters.

There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Eleven Million Nine Hundred Ninety-seven Thousand Four Hundred Fifteen Dollars (\$11,997,415.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Attorney General by law.

SECTION 130. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Three Hundred Twenty-six Thousand Dollars (\$326,000.00) to be transferred to the Court Appointed Special Advocates Revolving Fund created pursuant to subsection C of Section 2368.12 of Title 68 of the Oklahoma Statutes.

SECTION 131. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Nine Hundred Four Thousand Seven

Hundred Twenty-six Dollars (\$904,726.00) to transfer to the Legal Services Revolving Fund created pursuant to subsection G of Section 921.1 of Title 12 of the Oklahoma Statutes.

SECTION 132. For the fiscal year ending June 30, 2012, the Office of the Attorney General is authorized to transfer an amount not to exceed Three Hundred Twenty Thousand Four Hundred Thirty Dollars (\$320,430.00) from the Office of the Attorney General's Evidence Fund (700 Fund) created by Section 19 of Title 74 of the Oklahoma Statutes to the Office of the Attorney General's Revolving Fund (200 Fund) created by Section 20 of Title 74 of the Oklahoma Statutes.

SECTION 133. There is hereby appropriated to the Court of Criminal Appeals from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Three Million Three Hundred Thirty-four Thousand Six Hundred Thirty-one Dollars (\$3,334,631.00) or so much thereof as may be necessary to perform the duties imposed upon the Court of Criminal Appeals by law.

SECTION 134. There is hereby appropriated to the District Attorneys Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Thirty-two Million Eight Hundred Eighty-seven Thousand Two Hundred Fifty-eight Dollars (\$32,887,258.00) or so much thereof as may be necessary to perform the duties imposed upon the district attorneys and the District Attorneys Council by law. Of the funds appropriated herein, the District Attorneys Council shall transfer up to the sum of Four Hundred Ninety-one Thousand Fourteen Dollars (\$491,014.00) or so much thereof as may be required by the district attorneys and District Attorneys Council to the District Attorneys Evidence Fund for necessary expenses relative to any case within the official responsibility of the offices of the district attorneys as provided by Section 215.40 of Title 19 of the Oklahoma Statutes.

SECTION 135. For the fiscal year ending June 30, 2012, the District Attorneys Council is authorized to transfer an amount not to exceed One Million Dollars (\$1,000,000.00), on an as-needed basis, from the Crime Victims Compensation Revolving Fund created by Section 142.17 of Title 21 of the Oklahoma Statutes to the Sexual Assault Examination Fund created by Section 142.20 of Title 21 of the Oklahoma Statutes.

SECTION 136. For the fiscal year ending June 30, 2012, up to Seven Hundred Eighty-five Thousand Dollars (\$785,000.00) is authorized to be transferred from the Crime Victims Compensation Revolving Fund, created by Section 142.17 of Title 21 of the Oklahoma Statutes to the District Attorneys Council to support the Crime Victims Compensation Board.

SECTION 137. For the fiscal year ending June 30, 2012, up to One Million Five Hundred One Thousand Three Hundred Seventy-five Dollars (\$1,501,375.00) is authorized to be transferred from the Crime Victims Compensation Revolving Fund, created by Section 142.17 of Title 21 of the Oklahoma Statutes, to the District Attorneys Council for duties to support Victim-Witness Services.

SECTION 138. The Supreme Court is hereby authorized to expend during the fiscal year ending June 30, 2012, from the State Judicial Revolving Fund of the State Treasury, the sum of Fifty-two Million Dollars (\$52,000,000.00) or so much thereof as may be necessary for the financial support of the District Courts.

SECTION 139. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Seven Million Six Hundred Thousand Dollars (\$7,600,000.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 140. There is hereby appropriated to the Oklahoma Indigent Defense System from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Fourteen Million Six Hundred Ninety-nine Thousand Three Hundred Fifty-three Dollars (\$14,699,353.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Indigent Defense System by law.

SECTION 141. There is hereby appropriated to the Council on Judicial Complaints from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Seventy-five Thousand Dollars (\$75,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Judicial Complaints by law.

SECTION 142. There is hereby appropriated to the Pardon and Parole Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year

ending June 30, 2012, the sum of Two Million Two Hundred Seventeen Thousand Four Hundred Fifty-four Dollars (\$2,217,454.00) or so much thereof as may be necessary to perform the duties imposed upon the Pardon and Parole Board by law.

SECTION 143. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Seventeen Million Three Hundred Thousand Dollars (\$17,300,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Supreme Court or Court of Civil Appeals by law.

SECTION 144. For the fiscal year ending June 30, 2012, the Office of State Finance shall, at the request of the Administrative Director of the Courts, transfer from the Law Library Revolving Fund to the Supreme Court Administrative Revolving Fund an amount not to exceed Five Hundred Thousand Dollars (\$500,000.00) that the Administrative Director of the Courts, with the approval of the Chief Justice of the Supreme Court in his or her sole discretion, shall deem appropriate or necessary including, but not limited to, appellate and district court expenditures.

There is hereby appropriated to the Workers' Compensation Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Four Million One Hundred Ninety-seven Thousand One Hundred Sixty-six Dollars (\$4,197,166.00) or so much thereof as may be necessary to perform the duties imposed upon the Workers' Compensation Court by law.

SECTION 147. There is hereby appropriated to the Oklahoma State University Medical Authority Disbursing Fund from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Five Million Dollars (\$5,000,000.00) or so much

thereof as may be necessary to perform the duties imposed upon the Oklahoma State University Medical Authority by law.

SECTION 148. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2010, the sum of One Million Two Hundred Thousand Dollars (\$1,200,000.00) or so much thereof as may be necessary for the purchase of Oklahoma Statutes and Session Laws pursuant to the provisions of Sections 13 and 14 of Title 75 of the Oklahoma Statutes.

SECTION 149. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of One Million Four Hundred Sixty-three Thousand One Hundred Twenty-seven Dollars (\$1,463,127.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 150. There is hereby appropriated to the Office of the State Treasurer from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Three Million Five Hundred Thirty-six Thousand Eight Hundred Seventy-three Dollars (\$3,536,873.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Treasurer by law.

SECTION 151. There is hereby appropriated to the Office of the State Treasurer from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Ninety-three Thousand Dollars (\$93,000.00) or so much thereof as may be necessary to pay for state land reimbursements.

SECTION 152. This act shall become effective July 1, 2011 _____
