A Joint Resolution disapproving permanent rules of
the Board of Commercial Pet Breeders; and directing
distribution.

SUBJECT: Disapproving permanent rules of the Board of
Commercial Pet Breeders

WHEREAS, pursuant to Sections 250.2 and 308 of Title 75 of the
Oklahoma Statutes, the Legislature reserves the right to designate
the method for rule promulgation, establish policy, determine that a
rule is not consistent with legislative intent and disapprove any
rule or portion thereof at any time; and

WHEREAS, pursuant to Section 5005 of Title 59 of the Oklahoma
Statutes, the Board of Commercial Pet Breeders shall adopt the rules
necessary to enforce and administer the Commercial Pet Breeders Act;
and


WHEREAS, the promulgation of permanent rules OAC 532:10-2-
3(b)(22), 532:10-2-5(a), 532:10-3-2(a), 532:10-3-2(d), 532:15-2-9
and 532:15-3-3(d), which were finally adopted by the Board on
December 22, 2010, does not reflect the intent of the Oklahoma
Legislature.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
AND THE SENATE OF THE 1ST SESSION OF THE 53RD OKLAHOMA LEGISLATURE:

SECTION 1. The Legislature hereby disapproves permanent rules OAC 532:10-2-3(b)(22), 532:10-2-5(a), 532:10-3-2(a), 532:10-3-2(d), 532:15-2-9 and 532:15-3-3(d).

SECTION 2. The Secretary of State is directed to distribute copies of this resolution to the Governor, the Executive Director of the Board of Commercial Pet Breeders, and the editor of "The Oklahoma Register".


