A Concurrent Resolution commending Eddie Wilcoxon for his contributions to this state; congratulating Mr. Wilcoxon for his appointment as State Poet Laureate; and directing distribution.

WHEREAS, the English poet Matthew Arnold said, "Poetry is simply the most beautiful, impressive and widely effective mode of saying things"; and

WHEREAS, poetry is the imaginative treatment of experience through the heightened use of language; and

WHEREAS, poetry speaks to the soul, painting a picture with words, inspiring us and making us think about the universe around us; and

WHEREAS, the individual who personifies poetry for a society is its poet laureate; and

WHEREAS, the office of poet laureate historically has been a position bestowed upon a poet acclaimed as the most eminent in the locality; and

WHEREAS, the position of State Poet Laureate was established by the Oklahoma Legislature in 1994; and

WHEREAS, the Oklahoma Poet Laureate Program is designed to honor outstanding Oklahoma poets and promote participation in the literary arts of the state; and

WHEREAS, in 2011, Governor Brad Henry appointed Mr. Eddie Wilcoxon to the post of State Poet Laureate for the 2011-2012 term; and

WHEREAS, Mr. Wilcoxon is a distinguished writer of poetry, prose, and non-fiction; and

WHEREAS, Mr. Wilcoxon is a career radio broadcaster with a morning show on KWHW in Altus who is also widely recognized for his landscape design; and

WHEREAS, in 1996, Mr. Wilcoxon was designated an "Official Olympic Hero" and chosen to carry the Olympic Torch on its historic journey across the United States to Atlanta, Georgia; and

WHEREAS, Mr. Wilcoxon honors this state, not only with his considerable talent, but also his willingness to sharing his gift of stories and poems with others.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 1ST SESSION OF THE 53RD OKLAHOMA LEGISLATURE, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

THAT the Oklahoma Legislature, on behalf of the citizens of this state, hereby commends Mr. Eddie Wilcoxon for his valuable contributions to the State of Oklahoma.


THAT Mr. Eddie Wilcoxon is hereby congratulated for being designated State Poet Laureate, a post he fills in a manner that brings honor to the state.


