A Resolution expressing appreciation for the work of
Judi Grove for breast cancer awareness in Oklahoma;
and directing distribution.

WHEREAS, Judi Grove, through her selfless dedication and hard work, has been instrumental in raising awareness of breast cancer, and in supporting Oklahoma women who have experienced or lost a loved one from cancer. As Founder and Director of the nonprofit Breast Impressions Foundation, Judi Grove has helped to provide breast casting kits to women across Oklahoma and the United States, and to women as far away as Australia and the United Kingdom, who have recently been diagnosed with breast cancer; and

WHEREAS, Judi Grove, a native of Tulsa, is the wife of Bob Grove, mother to three grown children, and grandmother to five.

Grove founded Breast Impressions in 2007. After her own scare with breast cancer, her first thoughts were not of herself but of how she could help raise awareness of cancer in Oklahoma; and

WHEREAS, Judi Grove became the Oklahoma liaison for the national Pink Heals Tour in 2010, and was instrumental in the Tulsa Fire Department Local 176 receiving the Pink Fire Truck, after speaking at the Oklahoma IAFF Convention. Grove has also worked toward helping Tulsa receive a Pink Police Car and a Pink Ambulance. The pink vehicle wraps have all been donated by businesses throughout Tulsa. Through her efforts, Judi Grove has helped to raise awareness for cancer around the city of Tulsa, and will continue her efforts when the Turn Tulsa Pink event begins in Tulsa in October 2011; and

WHEREAS, Judi Grove has served as Chairwoman of "Breast Cancer Awareness Day" at the Oklahoma State Capitol for the past two years, and will continue her hard work and dedication in the planning of the 2011 "Breast Cancer Awareness Day." Grove is a member of the Oklahoma Women's Coalition, 2010 recipient of the Tulsa Business Journal Women of Distinction award, and the winner of the 2010 Civic Entrepreneur Tulsey Award; and


