

# An Act

An Act relating to the University Hospitals  
Authority; requiring transfers of certain funds; and  
requiring certain funds be used for certain programs.

SUBJECT: University Hospitals Authority

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1.       TRANSFER       The University Hospitals Authority shall transfer the sum of Five Hundred Thousand Dollars (\$500,000.00) from the funds appropriated in Section 88 of Enrolled Senate Bill No. 1975 of the 2nd Session of the 53rd Oklahoma Legislature to the University Hospitals Authority Disbursing Fund created by Section 3221 of Title 63 of the Oklahoma Statutes, to be expended in accordance with law.

SECTION 2.       TRANSFER       The University Hospitals Authority shall transfer the sum of Two Million Dollars (\$2,000,000.00) from the funds appropriated in Section 88 of Enrolled Senate Bill No. 1975 of the 2nd Session of the 53rd Oklahoma Legislature to the Oklahoma Institute for Disaster and Emergency Medicine Revolving Fund established pursuant to Section 1-2523 of Title 63 of the Oklahoma Statutes, to be expended in accordance with law.


SECTION 3.       TRANSFER       The University Hospitals Authority shall transfer the sum of Three Hundred Seventy-five Thousand

Dollars (\$375,000.00) from the funds appropriated in Section 88 of Enrolled Senate Bill No. 1975 of the 2nd Session of the 53rd Oklahoma Legislature to the Dental Loan Repayment Revolving Fund established pursuant to Section 1-2714 of Title 63 of the Oklahoma Statutes, to be expended in accordance with law.


SECTION 4. From the funds appropriated to the University Hospitals Authority in Section 88 of Enrolled Senate Bill No. 1975 of the 2nd Session of the 53rd Oklahoma Legislature, Three Hundred Fifty-six Thousand Dollars (\$356,000.00) shall be used for providing hearing services for deaf and/or hard of hearing children statewide.

SECTION 5. From the funds appropriated to the University Hospitals Authority in Section 88 of Enrolled Senate Bill No. 1975 of the 2nd Session of the 53rd Oklahoma Legislature, Three Million Dollars (\$3,000,000.00) shall be used for patient care at the University of Oklahoma Wayman Tisdale Specialty Health Clinic.
