A Concurrent Resolution educating our legislators and bringing support and awareness to the State of Oklahoma by designating May 15, 2012, as "Breast Cancer Awareness Day" in the State of Oklahoma.

WHEREAS, one in every eight women will be diagnosed with breast cancer in her lifetime; and

WHEREAS, breast cancer is the second leading cause of cancer deaths in women, and is projected to claim the lives of more than 39,000 women this year; and

WHEREAS, an estimated 226,870 new cases of invasive breast cancer will be diagnosed in women in 2012; and

WHEREAS, death rates from breast cancer have been declining since about 1990, with larger decreases in women younger than 50, with lower rates attributed to earlier detection through screening, increased awareness and improved treatment; and

WHEREAS, there are now more than 2.6 million breast cancer survivors in the United States; and

WHEREAS, men as well as women are at risk for breast cancer, and need to be educated about their risks.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

THAT the Oklahoma State Legislature recognizes the importance of breast cancer awareness and education for all men and women.

THAT the Oklahoma State Legislature designates May 15, 2012, as "Breast Cancer Awareness Day" in the State of Oklahoma.
