WHEREAS, the Boys & Girls Clubs have named March 29, 2012, as their annual "Day at the Capitol"; and


WHEREAS, through the years, Boys & Girls Clubs have encouraged young people to aspire to the highest level of personal development and to become good citizens who are involved in their communities.
