WHEREAS, in 1975, Neville Massie began her career in the Oklahoma Department of Corrections as a Probation and Parole Officer. She was promoted to Senior Probation and Parole Officer, Interstate Compact Officer and also served as Administrative Assistant to the Deputy Director of the Probation and Parole Division; and

WHEREAS, in 1985, Neville transferred to the Division of Programs and Services, working as Administrative Assistant to the

Deputy Director until 1987, when she was promoted to the position of Executive Assistant to the Director; and

WHEREAS, in August, 1989, Neville accepted the position of Deputy Warden for the Mabel Bassett Correctional Center. On February 19, 1992, she was assigned as the Acting Administrator for the Department's Construction and Maintenance Unit. On May 1, 1992, she accepted the position of Warden for the Mabel Bassett Correctional Center; and

WHEREAS, in 2004, Ms. Massie was appointed to the position of Assistant Deputy Director/Institutions of the West Central Region. She assumed the position of Executive Assistant to the Director on July 1, 2006, and serves as the agency's legislative liaison; and

WHEREAS, beginning July 1, 2014, Neville will begin the next chapter in her life, which will include more time for projects around the house, spending more time with family and friends, and going on road trips.
