An Act relating to disability insurance; amending 74 O.S. 2011, Section 1335, which relates to participation in the Disability Insurance Program; updating reference; authorizing cities to participate in the Program; providing for starting date for participation; providing for all employees of participating city to be covered; requiring city to provide certain contributions; directing the Oklahoma Employees Insurance and Benefits Board to determine contribution amount; and providing an effective date.

SUBJECT: Disability Insurance Program

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 74 O.S. 2011, Section 1335, is amended to read as follows:

Section 1335. A. A county, upon adoption of a resolution by the board of county commissioners, may participate in the Disability Insurance Program administered by the ~~State and Education~~ Oklahoma Employees ~~Group~~ Insurance and Benefits Board. Upon the filing of a certified copy of the resolution with the Board, the county shall become a participant on the first day of the second full month following the filing of the resolution. All employees of any county electing to participate in the Program shall have disability insurance coverage. The county shall forward to the Board, at such times as determined by the Board, the contributions necessary to pay for the disability insurance coverage of the employees of the

county. The Board shall determine the amount of contribution required for the disability insurance coverage.

B. A city, upon adoption of a resolution by the municipal governing body, may participate in the Disability Insurance Program administered by the Oklahoma Employees Insurance and Benefits Board. Upon the filing of a certified copy of the resolution with the Board, the city shall become a participant on the first day of the second full month following the filing of the resolution. All employees of any city electing to participate in the Program shall have disability insurance coverage. The city shall forward to the Board, at such times as determined by the Board, the contributions necessary to pay for the disability insurance coverage of the employees of the city. The Board shall determine the amount of contribution required for the disability insurance coverage.

SECTION 2. This act shall become effective November 1, 2016.
