SENATE JOINT RESOLUTION NO 6

A JOINT RESOLUTION AUTHORIZING THE SUB-  
MISSION OF A PROPOSED AMENDMENT TO THE  
CONSTITUTION OF THE STATE OF OKLAHOMA,  
AMENDING SECTION EIGHT OF ARTICLE NINE  
OF SAID CONSTITUTION.

BE IT RESOLVED BY THE SENATE AND THE HOUSE OR REPRESENTATIVES OF THE  
SEVENTEENTH LEGISLATURE OF THE STATE OF OKLAHOMA:

SECTION 1. That the following proposed amendment to Section  
8 of Article 9 of the Constitution of the State of Oklahoma be refer-  
red to the people of the State of Oklahoma for their ratification or  
rejection at the next general election held in the State of Oklahoma,  
or at any special election called therefor by the Governor; said  
Section 8 as amended to read as follows:

"No public service corporation, or the lessees,  
purchasers, or managers thereof, shall consoli-  
date the stock, property or franchises, of such  
corporation with, or lease or purchase the works  
or franchises of, or in any way control, any  
other public service corporation owning or having  
under its control a parallel or competing line,  
without the consent and approval of the Corpora-  
tion Commission of the State of Oklahoma. (This  
section shall not be construed to affect rail-  
roads, bus and truck lines.)"

SECTION 2. Said proposed amendment to Section 8 of Article  
9 of the Constitution of the State of Oklahoma shall be submitted as  
provided by law in the following form:

"Shall the proposed amendment be adopted?

SECTION 3. Said proposed amendment to the Constitution of  
the State of Oklahoma shall upon receiving a majority of all electors  
voting at said election, be adopted.
