A Joint Resolution directing the Secretary of State to refer to the people for their approval or rejection the repeal of Section 5 of Article II of the Oklahoma Constitution; providing ballot title; and directing filing.

SUBJECT: Constitutional prohibition against public expenditure and property use for religious purposes

BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE 2ND SESSION OF THE 55TH OKLAHOMA LEGISLATURE:

SECTION 1. The Secretary of State shall refer to the people for their approval or rejection, as and in the manner provided by law, the repeal of Section 5 of Article II of the Oklahoma Constitution which relates to use of public monies or property for sectarian or religious purposes.

SECTION 2. The Ballot Title for the proposed Constitutional amendment as set forth in SECTION 1 of this resolution shall be in the following form:

BALLOT TITLE

Legislative Referendum No. 369

State Question No. 790

THE GIST OF THE PROPOSITION IS AS FOLLOWS:

This measure repeals Section 5 of Article 2 of the Oklahoma Constitution. This section prohibits the use of public monies or property for sectarian or religious purposes.

SHALL THE PROPOSAL BE APPROVED?

SECTION 3. The President Pro Tempore of the Senate shall, immediately after the passage of this resolution, prepare and file one copy thereof, including the Ballot Title set forth in SECTION 2 hereof, with the Secretary of State and one copy with the Attorney General.



The statutorily required function of a ballot's title is to explain the effect of the proposition. The Proposed Ballot Title indicates that it is a repeal of Article 2, Section 5 of the Oklahoma Constitution, but does not fully explain what that provision prohibits or the effect of that provision's repeal.

Having found that the ballot title does not comply with applicable laws, we will, in accordance with the provisions of 34 O.S.2015, § 9(C), within ten business days, prepare a Preliminary Ballot Title which complies with the law and furnish a copy to each of you.





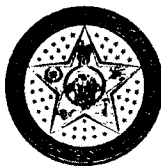

EXECUTIVE PROCLAMATION**

I, Mary Fallin, Governor of the State of Oklahoma, pursuant to the provisions of Section 3 of Article V and Section 1 of Article XXIV of the Oklahoma Constitution, Section 12 of Title 34 of the Oklahoma Statutes, and the referral by the Secretary of State, do hereby declare that Legislative Referendum Number 369, State Question 790, be submitted to qualified electors of the State of Oklahoma for their approval or rejection at the general election to be held statewide on November 8, 2016.

The substance of the measure is as follows:

This measure repeals Section 5 of Article II of the Oklahoma Constitution.

This section prohibits the use of public monies or property for sectarian or religious purposes.


